Stephen Curley spoke about the FY20 budget as both he, Linda Peterson and Stephen Walsh attended the Department Head meeting today. Departments are asking for more. Ed Thorne and Michael Buckley have not started going though it yet. He referenced an email from Michael Buckley, Town Accountant that we had \$510,209 left in Free Cash after the Fall Town Meeting. The Police Department is on pace to overspend their overtime budget by \$250,000. We need to cut 2.4M from FY20 budget. Advisory was invited to the Board of Selectmen meeting tonight to hear from Police Chief Rick Wall regarding his FY20 Budget.

The committee adjourned to the Board of Selectmen meeting in progress at 7:16PM.

Police Chief Rick Wall explained to the Board of Selectmen that he had a problem with the way his police budget spend was presented to him. Dan Trabuco said Ed Thorne, Town Administrator and Michael Buckley will look at the police budget and work together in January. Dan said "they understand what needs to happen and I'm confident we'll accomplish something".

Advisory adjourned from the Board of Selectmen meeting at 7:35PM

Stephen Curley noted that there are places where we can cut in the FY20 Budget. He asked members to review over the coming weeks and prepare to discuss further at their next meeting.

The next Advisory meeting is scheduled for Monday, January 7, 2019 at 7:00PM.
