Advisory received a Request for Transfer from The Reserve Fund from Ed Thorne, Town Administrator for replacement of water source heat pump at Town hall in the amount of \$6,200.

It was noted that any repair or purchase over \$10,000 would go out to bid.

Linda opened the discussion regarding the email from Tim Brennan regarding the maintenance of the grounds for all town property. Tim took pictures of town property i.e. town hall, library, council on aging, community center, etc. He noted shrubs are overgrown; memorial plaques' are covered w/debris and one tree at the library is completely dead. Tim also sent his email to Ed Thorne, Town Administrator who in turn forwarded to the DPW.

The committee agreed to send a letter to Gene Fulmine, DPW Director with a copy to the Board of Selectmen and DPW Commissioners asking the following questions:

- Is it the responsibility of the DPW to maintain the grounds of Town property in the center of Town specifically; Town Hall, Library, Council on Aging, Community Center, etc.?
- If so, how much time is being spent maintaining the grounds of these properties?
- It was noted that shrubs are overgrown and encroaching Town Memorial plaques' on display. Some of the trees appear to be dead and not cared for however the grass is mowed.
- The Advisory Committee respectfully request a response prior to their next scheduled meeting on Monday, July 25, 2016.

Tim asked what input the Planning Board has regarding development in town; specifically the new Taco Bell and Panera Bread restaurants. He noted the parking pattern seems to be a waste of space. Stephen Curley said the Planning Board confirms the developer plans meet the Town's Zoning regulations. The Planning Board is able to make suggestions and recommendations.
