#### **Swanberg Property -**

Commissioners reviewed a map of area to be given to us by Bob Penniman. It was stated that we need to look at the drainage easement and road run off first before we accept the land swap.

#### **Update on Hobomock Street -**

Gene updated the Commissioners on the Hobomock street paving project. Gene said all that needs to be done at this point is for Capone to come in and put in inch and a half top to the sidewalk and the driveway aprons on that side of the street, and next year we will micro seal.

#### Review of Comp time regulations -

Mr. Bastinelli asked Gene what Mr. Buckley had to say about trading funds. Gene said it is part of the snow ops and they are trying to find way to track it, so they know exactly what comp time is from the winter that we'd be looking to get the funds for. Mr. Bastinelli asked if we do or don't do comp time. Gene said we have to, or you'll open yourself up to grievances being filed. Further discussion ensued.
