At 7:00 pm, Mr. Trabucco advised that pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §20, and the Governor's March 15, 2020 Order imposing strict limitations on the number of people that may gather in one place, this public hearing of the Pembroke Board of Selectmen is being conducted via remote participation. No in-person attendance of members of the public will be permitted, but the public can view this meeting while in progress. CONSIDER SPECIAL EVENT PERMIT: CELEBRATION OF LIFE, 178 PLEASANT ST ON JULY 11^{TH} FROM 1:00-6:00 PM

Ms. Coletta moved to grant the application of Rocco LaMattina of 178 Pleasant Street for a Special Event Permit for a live band from 1:00 pm to 6:00 pm on July 11, 2020 subject to the approval of the Pembroke Police Chief. Ms. Rushing seconded the motion. By roll call vote: 5/0: Brown – yes; Coletta – yes; Marino – yes; Rushing – yes, Trabucco – yes.

VOTE SELECTMEN'S REPRESENTATIVE TO TOWN MANAGER'S SMALL BUSINESS RELIEF COMMITTEE

ANNUAL BOARD AND COMMITTEE REAPPOINTMENT: DAN PELLETIER AS BOS REP CPC, FAITH BYRNE, TOWN LANDING

Mr. Trabucco advised that the final two re-appointments include Daniel Pelletier, Selectmen's Representative to CPC for a term to expire 2023, and Faith Byrne, Town Landing Committee for a term to expire 2023. Mr. Brown moved the re-appointment of both with terms to expire 2023. Ms. Rushing seconded the motion. By roll call vote: 5/0: Brown – yes; Coletta – yes; Marino – yes; Rushing – yes, Trabucco – yes.

UPDATE, DISCUSSION AND POSSIBLE VOTE: TOWN MANAGER'S CARES ACT REIMBURSEMENT PLAN

Mr. Chenard advised that Plymouth County received \$90 million from the federal government for distribution to citied and towns in Plymouth County. Pembroke has identified \$704,000 in potential requests including computer hardware and software (\$653,446); PPE (\$11,008); cleaning and disinfecting supplies (\$14,161); signs, posters and more in town/school buildings and outdoor locations (\$1,496); payroll and staff overtime (\$19,180) and more (\$5,470). Mr. Chenard stated that Pembroke's allocations total \$1,544,080.44 broken out into three phases. In Phase One due July

10th, amount is population driven at \$808,560.76. Phase Two drops as it is population and case driven at \$586,702.46 with Phase Three at \$149,434.32 identified for veterans' services, library and COA costs incurred. Discussion ensued on necessary technological improvements, data upload technology versus staffing costs, school requirements and town meeting and election needs under COVID constraints. Mr. Chenard request a vote to approve costs as detailed in the presentation and the authorization to submit those costs for reimbursement. Ms. Coletta so moved. Ms. Rushing seconded the motion. By roll call vote: 5/0: Brown – yes; Coletta – yes; Marino – yes; Rushing – yes, Trabucco – yes.

Update: Town Hall Hours Change

Mr. Chenard advised that Veteran's Agent Robin Kernan is not seeking re-appointment; thanks were given for her work to date on behalf of Pembroke's veterans. Mr. Chenard stated that he is beginning the process of recruitment by evaluating needs, job description and timeline. Mr. Trabucco requested that the Town Manager invite a Selectman to participate in the process as the role is vital to the town,
