The members of the Zoning Board of Appeals hereby certify that the following is a detailed record of all the Board's proceedings regarding the petition of Maria Hoyo, 31 Gardner Lane, Pembroke, regarding property located at 31 Gardner Lane, as shown on Assessors' Map A-6, Lot 225, said property owned by Maria Hoyo, which is the property affected by this requested special permit.

The petition to the Board is dated September 22, 2017. The petition requests a special permit as per Sec. V, 5. Non-Conforming Property of the Zoning By-Laws of the Town of Pembroke to construct an addition to the second floor of the existing single-family dwelling.

A notice of the public hearing on this petition will be retained in the file. It was published in the Pembroke Mariner and Express, a newspaper of general circulation in the Town of Pembroke on October 6, 2017 and October 13, 2017, posted in a conspicuous place in the Town Hall and mailed on October 6, 2017 to abutters whose property is located within 300 feet of the property line of the property in question.
