The Commission On Disabilities was established in 1991, to make the residents aware of the ADA laws and to make town owned buildings and properties compliant with the ADA laws. Some of the accomplishments the Commission has made through the years are transportation for the disabled residents under 60 years old, HP ramp on town green, HP access to all public buildings and town owned properties—town hall, library. Working with the building inspector on the Birch Street playground, also the Herring Run. The Commission accepts donations of medical equipment. Said equipment must be in good condition and not have any broken or missing pieces. Other donations accepted are used prescription eyeglasses, TTY telephone equipment and small pieces of fitness equipment (that can be carried out easily).

Many times I have been asked for names of companies that carry medical supplies. The Pembroke C.O.D. has a substantial reference list of Medicare and Medicaid approved Healthcare Suppliers and Medical equipment. Call the office for a list of local vendors.
