Pembroke Conservation Commission Minutes of the Meeting of May 6, 2019 Pembroke Town Hall, Room 3

At 7:00PM, Mr. Mark Sotir, Chairman, opened the meeting and asked the members to introduce themselves, and then stated that the proceedings would be made available to the public through video or audio broadcast on the PACTV Government Access Channel for broadcast at future dates and that all comments made in open session would be recorded.

ADMINISTRATIVE BUSINESS

Minutes of the meeting

A vote to approve the minutes of the April 22, 2019 was postponed to the next scheduled meeting, as Mr. Madden requested an amendment.

HEARINGS

Request for Determination of Applicability (RDA) – 242-244 Mattakeesett Street – Johnson Attendees: Mr. Michael Johnson, applicant

The applicant explained the plan – utility installation for a tree house bar with erosion controls – to the members. The agent informed the applicant that 12" silt sock was required for erosion control measures.

A motion was made by Mr. Boidi and seconded by Mr. Madden to close discussion. All in favor. Motion passed unanimously.

A motion was made by Mr. Egerton and seconded by Mr. Boidi to issue a negative 3 determination and to include a stipulation regarding the 12" silt sock. All in favor. Motion passed unanimously.

UNFINISHED BUSINESS

Tree cutting at Bicentennial Trail

The agent informed the members that a formal document for signature by the property owner adjacent to the entrance of Bicentennial Trail was requested to be drafted by the board of selectmen's office; however, as of today, a response has not been received.

UNSCHEDULED DISCUSSIONS

Mr. Fellini asked to read a statement he had prepared regarding the enforcement order the agent issued for the dumping of granite block at 211 Barker Street. The text of Mr. Fellini's statement, as written by him and read by the chairman, is as follows

Measures are taken every year in order to promote the safe passage of anadromous species, our alewife or herring, through a myriad of manmade obstacles.

To improve the success rate and to prevent unnecessary mortality, measures are taken every year and monitored, too increase the herring population.

Previously, rocks and sand bags have been used with mixed results. This year granite blocks were available and better suited in maintaining their position in high volume, high velocity stream conditions. This was due to the recent heavy rains we have been experiencing.

The square to rectangular blocks allegedly in violation, wee WPA9 Enforcement Order SE056-1025, were deemed a more suitable alternative to either rolling rocks or deteriorating sandbags. This use is supported by the DMF who Pembroke Fisheries supported and assisted in this endeavor.

All the granite blocks delivered to this site at 211 Barker Street have been strategically placed in and at the water's edge successfully mitigating safe passage and resulting in Zero mortality in "the kill zone" adjacent to the concrete spillway of the inner brook.

Note that this Enforcement Order has not been endorsed by all members of the Pembroke Conservation Commission. The Conservation Agent acted without previous consent and notice to the board members.

A motion was made and seconded to rescind the order and it did not pass, resulting in a 3-3 tie.

Care and maintenance for the safety of the herring has been performed for centuries, far longer than the advent of the WPA9 Enforcement Order. The actions taken are designed to remove obstructions allowing fish passage with no alteration or impedance of wetland functions of WPA performance standards.

The agent reiterated that the enforcement order was properly issued for the dumping of granite blocks in the buffer zone without a permit.

A motion was made by Mr. Boidi and seconded by Mr. Clarke to close the meeting at 8:09PM. All in favor.
