Agent's Report: Edgewood Bog Violation – Mr. Clarke informed the commission that he was informed by the NRCS that someone cut down trees and cleared brush at the Edgewater Bog in April. This easement is under control of the federal government. The property is owned by the town for the well and DPW use. The violation is the responsibility of the town since they are the landowners. Mr. Clarke has spoken with NRCS to come up with a solution to rectify the situation. The majority of trees cut were pines, maples, and brush. Planting up to 100 Northern White Cedar trees as replacements has been deemed acceptable, to be done in the spring. A letter will be drafted to NRCS. The person believed to have done the cutting has been spoken to, as it looks as though it was done to clear the pond view. The town is determining if any damages can be recovered. Money to pay for the trees can come from the Conservation Forestry account. Mr. Boidi suggested reaching out to the Mass Forestry Service to determine if a forestry plan could be created for this lot. Mr. Clarke stated that most likely would not be applicable to this situation. Mr. Boidi will look into the Forestry Service for future projects.

## Notice of Intent (NOI) - DEP # SE056-1052) - 48 Copperwood Road

In attendance: Eoghan Kelley, Copperwood Circle Builders; Dave Newhall, Merrill Engineers

The proposed project is a single-family home with septic and associated utilities and site grading. The entire lot is within the buffer zone. Closest point to the wetlands is 2' off the back deck, 10' off the back of the house. Mr. Boidi suggested outlining the resource line with large boulders along with the wetland markers to decrease encroachment into that wetland area as time goes on. Mr. Kelley agreed to include boulders, signs, and vegetated barrier to create an obvious natural line.

DEP has not issued a file number yet, therefore the hearing cannot be closed. The project is a proposed 2 car garage within the 100' buffer zone. The resource area is within 3' of the corner of the proposed garage. It is a previously disturbed area, so no grading, fill or clearing needs to be done. Mr. Egerton

asked if the proposed garage could be smaller or further away from the resource area. Mr. Garfield proposed reducing the size and possibly changing the orientation of the proposed garage as well as including a line of boulders, vegetated barrier, as well as signs along the line of the resource area to be presented at the next meeting. Mr. Clarke suggested boulders every 6' with vegetated barrier in between as an acceptable solution. Instead of drywells, a rain garden was suggested by Mr. Madden.
