#### Notice of Intent – DEP #SE056-1080 – 35 Misty Meadow Road

This Notice of Intent is to construct a water dependent pier consisting of a timber walkway, aluminum gangway, and float. Proposed pier will be constructed on piles and elevated over the resource area. Chapter 91 Waterways permitting will be required, representative is looking for an OOC prior to starting that process. Proposed work approved by North River Commission.

Commission requests an on-site pre-construction meeting with all parties in attendance.

## Request for an Amended Order of Conditions – DEP #SE056-1022 – 50 Allen Street

In attendance: Kevin Grady, Grady Consulting

Amended plans propose 804sf of new alteration with 1619sf of additional replication in the rear of the property. Existing lawn area in rear of house will have native plants added and connect to existing BVW. Replication area will be staked out prior to work commencing. New owner will sign wetland notification form. Replication will require monitoring for 2 growing seasons. Mr. Clarke stated that this replication must be started within one year and completed within 5 years.

This does not change the expiration date of the OOC, which remains at 12/3/2022 – applicant will need to extend this until 2 growing seasons have occurred after replication is complete.
