Acting chairperson Art Egerton opens meeting and states that "Please note that this meeting is being made available to the public and is being recorded for broadcast at future dates. Comments made in open session will be recorded".

Discussion: Wild Parsnip at Herring Run Park

No one in attendance.

Member Rick Madden provides an overview of his research into the methods available to eradicate Wild Parsnip. 1.) Steam wands are effective to knock it out; and 2.) Removal and relocation of the plants and soil (with seeds) located outside the resource area to a non-sensitive area to be treated chemically is also effective. He states that the commission must monitor the area vigilantly for 2 to 3 years for whatever method is used. He would like the commission to consult an agricultural board for further advice and direction. The commission also discussed: possible spread of the infestation due to upcoming work in the area from the Route 14 reconstruction project; possible legislative support for removal costs; and education of the public regarding exposure hazards.

Discussion: Tree Removal at Town Barn

Agent Bob Clarke informs the commission that Assistant DPW Director and member Scott Glauben that the quote for the removal of approximately 150 trees by crane was approximately \$9,000.00. Mr. Clarke has since discussed the removal with a forester who stated that the understory brush would recover quickly and does not need to be protected during the removal process. He thinks that the commission and DPW should investigate the tree removal further.

RDA - 171 Wampatuck Road - Anderson

Hearing opened at 7:50 p.m.

Present: Shane McGlone, McGlone Enterprises, Inc. representing applicant (not present)



The subject proposal involves the removal of an existing cesspool from a single family house within the bufferzone of Oldham Pond. The upgrade consists of a 1,500 gallon septic tank with a 5.66 foot by 31 foot infiltrator trench leaching field which will be installed at a distance of 80 feet from the edge of Furnace Pond. No soils will be stockpiled on site and erosion controls consisting of double staked haybales or a silt sock having a diameter of eight (8) inches or greater with wood chips on the upland side will be used for erosion controls.

- Subject to Board of Health approval;
- Erosion controls consisting of double staked haybales or silt sock having a diamer greater than 8 inches must be installed and installation approved by the conservation agent prior to the commencement of work; The use of silt fence is not allowed; and
- No stockpiling of soils is allowed on site.
