## Notice of Intent (NOI) - 42 Blueberry Lane - Patt (DEP file no.: SE56-964)

Mr. Self submitted green cards and photographs of the site.

The subject proposal involves the razing and rebuilding of a single family house located on a 9,926 square foot lot abutting Stetson Pond. A second resource area consisting of cranberry bogs is located across Blueberry Lane. The existing house is located on the retaining wall. The proposed new construction will result in an open deck on the pond side of the site structure and will move the house back from the retaining wall. The new single family house will be situated on a crawl space/slab foundation as allowed by building code. A permit from the zoning board of appeals will also be required.

The commission reviewed the plans and submitted photographs for discussion on the following items: removal of debris from razing the house (will be loaded onto trucks and moved offsite); stockpiling of materials during excavation and construction (the proposed location of a garage will be used for stockpiling); location of a concrete washout station (also in the vicinity of the proposed garage); tree removal (maybe two); repair of the retaining wall located on the southeast corner of the lot (the repair is to be performed from the upland side of the site, unless such work is performed by hand; no equipment or material storage will be allowed in the resource area); and fertilizer use (fertilizers must be slow release low-nitrogen types within 50 feet of the resource areas).
