Kevin Grady submits green cards as proof of abutter notice.



Mr. Grady presents an overview of the site. He states that John Zimmer of South River Environmental delineated the site in November of 2015. Mr. Grady is looking for approval of the edge of the bordering vegetated wetland and top of bank for an intermittent stream. He is only requesting a determination of one bank. Mr. Grady informs the commission that Mr. Zimmer, in his report, stated that it is an intermittent stream based on his review of the USGS map dated 2015. This USGS map did not indicate the presence of a perennial stream on-site; there was no observations of a dry stream; and a Stream Stats analysis of the watershed was not performed. Mr. Grady informs the commission that since the stream hit the first test (not shown on the USGS map), he stopped investigating its status.

Mr. Grady provided a definition of a perennial stream vs. an intermittent stream and the commission provided a brief overview of the regulatory impacts of an intermittent determination.

All of the abutters claim that the stream flows all the time. Bruce Nichols of 145 Mountain Avenue states that he has lived there for 50 years and it has always been flowing. Member Rick Madden agrees that the stream runs all year.

An abutter requests that another person investigate the determination as the people who live next to the stream have a different viewpoint. He asks that if the board thinks that there is a concern, that they should 'kick it up' to another board. Chairperson Andy Stevenson says that the town does not have the authority to make decisions or changes to the USGS map. Mr. Nichols questions whether the town had information on the abutting town property and he requests that the town take the intermittent stream designation off of the plan. Mr. Grady states that he has submitted the request so that his client can make design decisions based on the commission's determination.

Agent Bob Clarke requests a continuance of 30 days to allow all parties to research the data. Mr. Madden and the abutters state that the map may be inaccurate and would like the applicant to come back with more information. Mr. Grady does not think it is in his client's best interest to continue the hearing. Mr. Grady would like a vote of the board.

Agent Bob Clarke says that he is ready to accept the b.v.w as accurate, but not the top of bank.

Green cards were submitted as proof of abutter notice.

The subject proposal consists of a 23 acre parcel which will be developed with a 650 foot cul-de-sac subdivision with 6 house lots and stormwater drainage. The commission approved an Order of Resource Area Delineation on August 30, 2016 for the site and the approved wetland line is shown on the plan. The existing single family house currently located on site will be razed and removed. The site is located in priority habitat and a determination has already been received from the Natural Heritage and Endangered Species Program (NHESP). Silt sock is proposed for erosion control.

All stormwater will be directed to the drainage basin. The system has been sized for 100 year storm. The project will have three rain-gardens for driveway runoff, the maintenance of which will be the responsibility of the homeowner. Drywells will be installed for roof runoff. The maintenance of the retention basin will become the responsibility of the town.

Each lot will file an individual Notice of Intent. All percolation tests have been performed outside the 100 foot bufferzone.

Chairperson Andy Stevenson asks if abutters have questions or comments. They state that they are here to listen.

Tyler Nims, PE will be performing the subdivision review for the Planning Board. The commission will request that Mr. Nims review the stormwater system for compliance with MassDEP regulations.
