At 7:30PM, Mr. Richard Madden, Vice Chairman, opened the meeting and stated that the proceedings would not be made available to the public through video or audio broadcast on the PACTV Government Access Channel for broadcast at future dates, but that the proceedings would be audio recorded by the secretary for purposes of the meeting minutes.

OLD BUSINESS

Chimney/woodstove at Herring Run Park

Mr. Madden has located a gentleman who works exclusively on chimneys to look at the chimney on the building at Herring Run Park. This gentleman plans to make an inspection of the chimney on Tuesday, March 28.

Planting of trees

The vice chairman asked the administrative agent to draft a letter to the DPW commissioners requesting permission to plant cedars at Bog 12.

Bicentennial Trail

Abreviated Notice of Resource Area Delineation (ANRAD) – 715 Washington Street – Spurling

Invitees and attendees: Kevin Grady, Grady Consulting, L.L.C.

Mr. Grady gave an overview of the project and details about the property. The property contains what is referred to as an "intermittent" stream - it was deemed intermittent because it does not flow continuously and is quite often dry. Mr. Grady explained that the property has been studied by a wetlands expert and he provided delineation maps showing the wetlands and photographs of the dry stream bed.
