ADMINISTRATIVE BUSINESS

Meeting minutes

A motion was made by Mr. Clarke and seconded by Ms. Simon to accept and approve the minutes of the November 13, 2017 meeting. All in favor. Motion passed unanimously.

DISCUSSIONS

Letter drafted by Mr. Sotir to the city of Brockton regarding the fish kill at Silver Lake Mr. Sotir read aloud to the members the letter he drafted regarding the mismanagement of water resources and the associated fish kill at Silver Lake. There was discussion about including the selectmen's office in any revisions to the letter. The members agreed that it was a good draft and that after revisions, it should be sent to the mayor of Brockton, the Brockton water commissioners, and other entities specified on the letter.

PUBLIC HEARINGS

Request for Determination of Applicability (RDA) – 314 Mattakeesett Street – Map B7, lot 274 – Worrall

Mr. Shayne McGlone of McGlone Enterprises, Inc. informed the members that this RDA was filed as an after-the-fact RDA due to an emergency with the septic system at 314 Mattakeesett Street. The job has been completed, accepted and approved.

A motion was made by Mr. Clarke and seconded by Ms. Simon to close the hearing. All in favor. Motion passed unanimously.

A motion was made by Mr. Clarke and seconded by Mr. Sotir to issue a negative 3 determination. All in favor. Motion passed unanimously.

Request for Determination of Applicability (RDA) – 27 Forest Street – Map E7, lot 19a – Pilkuhn

The home at this address will soon be sold. The existing septic and plumbing is behind the house, so the new septic will also be installed behind the house and the leaching field will be at the side of the home. The current system is in the water table, the proposed system will be above the water table. The plan has been approved by the Pembroke Board of Health.

A motion was made by Mr. Clarke and seconded by Mr. Sotir to close the hearing. All in favor. Motion passed unanimously.

A motion was made by Mr. Clarke and seconded by Mr. Sotir to issue a negative 3 determination. All in favor. Motion passed unanimously.

Request for Determination of Applicability (RDA) – 7 West Fish Street – Map B3, lot 2990 – Costa

Mr. McGlone reviewed the plan with the members and pointed out that there is a significant slope on the property that creates the need for the installation of a stone wall. The plan shows the stone wall and Mr. McGlone confirmed the wall will be built prior to the installation of the septic system.

A motion was made by Mr. Clarke and seconded by Ms. Simon. All in favor. Motion passed unanimously.

A motion was made by Mr. Clarke and seconded by Ms. Simon to issue a negative 3 determination. All in favor. Motion passed unanimously.

A motion was made by Ms. Simon and seconded by Mr. Sotir to close the meeting at 7:53PM. All in favor.
