CONSIDER 90 DAY EXTENSION OF FIRST RIGHT OF REFUSAL: 51 REDWOOD CIRCLE

Mr. Boyle moved to extend the Town's Right of First Refusal on 51 Redwood Circle, Pembroke for a period of 90 days. Mr. Stone seconded. The vote was unanimously in favor.

RECLASSIFICATION REQUEST: VETERANS' OFFICE, POLICE DEPARTMENT

Mr. Thorne stated that a request was received by David McPhillips, Veterans Service Officer, for reclassification of the position of Principal Clerk to Assistant Veterans' Service Officer/Administrative assistant. Mr. Boyle moved, acting as the Wage and Personnel Board, to grant the reclassification of position of Principal Clerk to Assistant Veterans' Service Officer/Administrative assistant. Mr. Stone seconded; the vote was unanimously in favor. Mr. Thorne stated that a request was received by Chief Michael Ohrenberger for reclassification of the position of his current Secretary-Assistant to Administrative Assistant and his Principle Clerk to Secretary. Mr. Boyle moved, acting as the Wage and Personnel Board, to grant the reclassification of position of Secretary-Assistant to Administrative Assistant and the position of Principle Clerk to Secretary. Mr. Stone seconded; the vote was unanimously in favor. Mr. Boulter inquired as to when these reclassifications would take effect. Mr. Thorne stated July 1, 2012.

OPEN SPECIAL TOWN MEETING WARRANT

Mr. Boyle moved to open Special Town Meeting Warrant with anticipated close of March 29 at 4:00 pm. Mr. Boulter seconded the motion. The vote was unanimously in favor.

Mr. Stone moved and Mr. Boyle seconded to accept the minutes of the meeting of March 19, 2012 as presented. The vote was unanimously in favor.

TOWN ADMINISTRATOR'S REPORT

Mr. Thorne updated the Board on the Household Hazardous Waste Day held Saturday, March 24. This year's combined totals for the two events were consistent with last year's totals.

ASK THE SELECTMEN

Mr. Boulter mentioned, during a discussion on the new electronic speed control machines, that residents may contact the police department and request that the machines be placed on their streets if they believe speeders to be an ongoing problem on their streets. The Chief will try to prioritize the placement of the machines by the volume of the requests or by need at his discretion.

EXECUTIVE SESSION: Mr. Stone moved, seconded by Mr. Boyle, to go into executive session to discuss strategy with respect to collective bargaining or litigation if an open meeting may have a detrimental effect on the bargaining or litigating position of the public body and the chair so declares concerning T-Mobile vs. Pembroke ZBA, and upon conclusion no further votes or public business to be discussed.
