TOWN OF PEMBROKE APPROVED ADVISORY COMMITTEE MINUTES 4 OCTOBER 2021

Linda Peterson, Chairperson opened the meeting of the Advisory Committee, in person at Town Hall at 7:00PM on October 4, 2021.

Also present were: Stephen Walsh, Sandra Beaton, Kristi Cullinane John Scholl, Liz Benotti and Matthew Rushing

Absent: Tim Landy, Robert Kenney **Guests:** Bill Chenard, Town Manager

Resident Maureen Jaycee stopped by at 8:05pm to observe

Linda opened the meeting and welcomed Bill Chenard.

Bill provided a handout of the FY22 Q1 Expenses; the quarter closed 9/30/21. He highlighted the expenses that are paid at the beginning of the fiscal year:

Inspectional Services – Two bills were paid, one for \$7,000 and another for \$8,000. The \$8,000 bill was for software which should have been paid by DPW; they will do an internal transfer to the DPW.

Town Landing – Bill has some concerns; he expected to be at 96%. Registration for swim lessons opens in June; there is a revolving account for swim lessons. Debt schedule was loaded in July and it was unknown at the time the additional funding needed for ADA Exterior components and interior finishes. We'll close under budget if Advisory votes this funding request of \$15,000 on Article 4.

Retirement – pay 100% of expenses in July to save money. Liz Benotti asked how many people this covers. Bill said hundreds but would get the exact number for Advisory.

Unemployment Compensation is low; just a pay back to the town. UE started as school employees just kicked in. **Health Insurance & Life Insurance** — on track

Medicare Tax at 17% - this will come up

Property & Liability Insurance – by paying the premium up front, we have additional savings. Bill said they looked at the entire list of town vehicles and equipment, if insured; 3,500 vehicles with a \$5,000 deductible and took those off to reduce what they would have been paying.

FY22 Q1 Revenue – still waiting to turn over and hit the bank – above 25%

Linda asked Bill what he sees as the biggest threat to Pembroke. Bill said the water system is the biggest costs and a big frustration as rates can fluctuate and not understanding why we get brown water. There could be many reasons, possibly a leak in a main line.

Linda raised the question as to whether the Warrant Articles could be taken out of order during Town Meeting for quorum purposes. If Article 9 – The Citizens Petition is randomly selected first, is there an option to make a motion for this to be taken last. Bill Chenard said The Select Board can vote to reduce the quorum before the meeting. So the Select Board would first vote to reduce the quorum and the Town would take a vote for Article 9 to be voted last. Bill said he would have this discussion with the Select Board.

The Committee reviewed and discussed the Special Town Meeting Warrant Articles and voted their recommendations as follows:
