## TOWN OF PEMBROKE APPROVED ADVISORY COMMITTEE MINUTES 24 AUGUST 2022

Linda Peterson, Chairperson opened the meeting of the Advisory Committee at Town Hall at 6:30PM on 24 August 2022.

Also present were: Sandra Beaton, Liz Benotti, Tim Landy, Stephen Walsh and Kristi Cullinane

Absent: Robert Kenney, Matthew Rushing, John Scholl

Guest: Bill Chenard, Town Manager

Linda welcomed Bill.

Bill reviewed **FY22 Expenses** and noted two categories in red/yellow; Snow & Ice and Debt Service Principal. Snow & Ice is managed through Town Meeting and the Debt Service Principal is in the red by two pennies. They have not received all the bills for Town Counsel; they'll be dated after July 1<sup>st</sup>. Bill noted a transfer of funds will be needed for Postage for the Town Clerk due to mail-in ballots for three elections;\$2,800 was budgeted but will need \$20,000. There was \$577,000 turned back which adds to the Free Cash balance.

**FY22 Revenue** – There is a substantial amount in Care Funding; unexpenditure from last year 2M; Meals Tax \$60,000 – came in over projection. State Aid is zero balance due to Charter School Reimburement. Bill noted school enrollment is down for this upcoming year. The proposed State Certification will come in at 1.9M - 2.7M; should be certified by the fall.

**ARPA funds** – allocated funds expended \$253,110; received \$968,655 – getting next month. Plymouth County Funds 3.5M but likely to commit to 2.6M. They're not required to give us money.

The Select Board has idenfitied projects elibigle for ARPA funds.

- Congress Street Culvert is eligible the cost is \$680,000 to \$710,000. Grant funding was denied.
- Community Center \$310,000
- Water Infrastructure Swanberg 4.5M still need to borrow. Wells are in good shape.
- Adjustments to Capital Plan adding a couple of small projects.

Bill said the Capital Plan is a five year plan and updated every August. Tim Landy asked about receiving a copy.

Street paving was discussed and Bill was asked about the repair to the pavement at the Recyling Center. Bill said it's the pad where the Dumpters sit that needs repair. He said the Chapter 90 money including stimulus is about \$900,00 to 1M. The conversation continued about the number one complaint from residents being road repairs. Bill said there is a list of streets for paving which he belives may be posted on the website but will doublecheck. He would commit to submitting an Article for Town Meeting requesting 2M in funding for street paving. The last time this request was submitted to Town Meeting, the town voted it down.

The committee reviewed and discussed the Capital Items listed on the fall Town Meeting Warrant.

Bill updated the committee on the Community Center Project. A public meeting on August 23<sup>rd</sup> that went well. Bids are out and due 8/31/22. The budget for the building is \$19.6M and is estimated at 22.6M. There is grant money available from Senator Markey and Senator Warren's offices. Bill encouraged everyone to reach out to our Senators to support funding for Pembroke's Community Center.

There will be a joint meeting via ZOOM on Wednesday, September 7<sup>th</sup> at 7:00PM with the Select Board, Advisory Committee, Recreation Commission and Council on Aging to discuss the Community Center Bids. All are encouraged to attend.
