## TOWN OF PEMBROKE APPROVED ADVISORY COMMITTEE MINUTES 12 September 2016

Linda welcomed members back. The following correspondence was reviewed:

- Preliminary Free Cash Estimate email from Michael Buckley, Town Accountant
- Application received from resident James L. Gallagher, II he is interested in filling a board vacancy – 1) Open Space, 2) ZBA and 3) Advisory. The committee agreed to see what happens with his first and second choices.
- Memo received from Ed Thorne, Town Administrator reminding committees to post their meeting minutes once voted by its members. Advisory is in compliance.

Stephen Walsh, John G. Brown Jr. and Elizabeth Monks supported the motion.

**Article 3** – To see if the Town will vote to raise and appropriate and/or transfer from available funds a sum of money to be added to the Stabilization Fund, or take any action relative thereto.

**VOTED**<sup>3</sup>: Favorable Action in agreement with the recommendation of the Town Accountant, Michael Buckley that \$25,000 is added to the Stabilization Fund. Stephen Walsh, John G. Brown Jr. and Elizabeth Monks supported the motion.

**VOTED**<sup>4</sup>: Favorable Action transfer from surplus revenue and/or other available funds a sum of money to balance the budget and to reduce the tax rate from the Fiscal year 2017 by providing for last year's snow and ice deficit of \$537,347. Stephen Walsh, John G. Brown Jr. and Elizabeth Monks supported the motion.

**Article 5** – To see if the Town will vote to appropriate a sum of money to be added to the Other Post-Employment Benefits Liability fund established by the vote of Article 11 of the April 24, 2012 Annual Town Meeting, or take any other action relative thereto.

**VOTED**<sup>5</sup>: Favorable Action in agreement with the recommendation of Town Accountant, Michael Buckley that \$250,000 is added to the Other Post-Employment Benefits Liability Fund. Stephen Walsh, John G. Brown Jr. and Elizabeth Monks supported the motion.
