TOWN OF PEMBROKE APPROVED ADVISORY COMMITTEE MINUTES 03 APRIL 2017

Chairperson Linda Peterson opened the meeting of the Advisory Committee in Pembroke Town Hall at 7:30PM on 03 April, 2017. Also present were Stephen Curley, Timothy Brennan, James McCollum, John G. Brown, Jr. Stephen Walsh, and Elizabeth Monks

Absent: Richard McManus

Guest: Mr. Bryant; Ed Thorne, Town Administrator; Sabrina Chilcott, Executive Assistant

The committee reviewed and discussed the meeting minutes of March 27, 2017. The last names for two guests were not included; they are Mary Beth Brust, Assistant School Superintendent and Mathew McNeilly.

Upon motion moved by James McCollum 2nd by John G. Brown Jr. following the discussion it was

VOTED¹: To accept the amended minutes (with corrected names of two guests as noted above) of 27 March 2017. Stephen Curley, Timothy Brennan, Stephen Walsh and Elizabeth Monks supported the motion.

Advisory reviewed and discussed the Special Town Meeting and Annual Town Meeting Warrant Articles as follows:

Special Town Meeting Warrant Articles

Article 1 – To see if the town will vote to authorize transfers to supplement FY17. Linda Peterson and Stephen Walsh attended the Department Head meeting on Friday, March 31, 2017. Ed Thorne, Town Administrator made it clear that the FY18 Budget is balanced and there is no additional funding available. Ed identified the Property and Liability Insurance figure as \$5,000; specific to this article. Funding for this article will come from the Overlay Surplus.

Upon motion moved by Stephen Curley 2nd by Stephen Walsh following the discussion it was

VOTED²: Favorable Action Article 1 - To see if the town will vote to authorize transfers to supplement FY17. Timothy Brennan, James McCollum, John G. Brown Jr., and Elizabeth Monks supported the motion.

Article 2 – Pembroke High School – installation of a Turf Field at a cost of \$700,000. The wording of the article needs to be changed to say it is to be paid for by the Pembroke School Department. If this language is amended Advisory agreed to vote Favorable Action.

Upon motion moved by Stephen Curley 2nd by Stephen Walsh following the discussion it was

VOTED³: Favorable Action Article 2 - Pembroke High School – installation of a Turf Field at a cost of \$700,000, only if the language is amended to say "paid for by the School Department". Timothy Brennan, James McCollum, John G. Brown Jr., and Elizabeth Monks supported the motion.

Article 3 – NexGen 911 Equipment purchase – estimated cost \$25,000. Ed Thorne, Town Administrator explained that the Police Department received a grant to cover part of this funding. The Fire Department wants the new system to ring on three phones versus one in the fire house. The revised amount of funding needed is \$10,000; they are looking at taking it from the Emergency Management budget. More explanation is needed from Police Chief Wall before

Advisory votes their recommendation. Ed noted the Board of Selectmen voted Favorable Action.

Article 4 – Purchase of one Police Cruiser – estimated cost \$45,000. No funding available to support this article. Ed noted the Board of Selectmen voted Town Meeting Floor.

Article 5 – To see if the Town will vote to transfer from water surplus of \$360,000 for the Water System Improvements associated with the Route 14 Corridor Project. Ed noted the Board of Selectmen voted Favorable Action.

Ed noted that the Board of Selectmen must obtain the deed in order to sell the property; the Board of Selectmen voted Favorable Action.

Linda was told that the town treasurer/collector does not want to withhold livestock permits to residents in arrears on their taxes. The town does not have the capacity to house such livestock.

How does the Firehouse Pantry qualify for this funding? **Advisory will invited Brian Van Riper, CPC Chairperson to their meeting on Monday, April 10, 2017 to discuss this article and recommendations.**

Articles 28 – to ask the Town of Pembroke to vote to raise or appropriate or transfer available funds, the sum of \$3,500 to contract with the South Shore Women's Resource Center for domestic violence intervention and prevention services for its residents. Advisory postponed vote until the meet with Ed Thorne, Town Administrator and Michael Buckley, Town Accountant on Monday, April 10, 2017.

Articles 29 – to see if the Town of Pembroke will vote to raise and appropriate and/or transfer from available funds, the sum of \$1,500 for the purpose of supporting services provided to survivors of sexual assault and domestic violence to be administrated by VIOLENCE INTERVENTION AND PREVENTION PROGRAMS. **Advisory postponed vote until the meet with Ed Thorne, Town Administrator and Michael Buckley, Town Accountant on Monday, April 10, 2017.**

Article 30 – to see if the town will vote to amend the Pembroke By-Laws, Article XXII "Junk Motor Vehicles: by deleting Section 4 and replacing with new language.

VOTED²⁷: Favorable Action - Article 31 – to see if the town will vote to amend the Town of Pembroke Bylaws, Article XXII – Miscellaneous, by adding Section 25 "Right to Farm". Stephen Curley, John G. Brown Jr., Stephen Walsh and Elizabeth Monks supported the motion.

Ed was asked about the increase for healthcare for FY18. He said the increase came in at 11.5%. They plan to budget 14%; round off to 1/2% and a cushion of 2% for unexpected. He said the cost to the town for a family plan is approximately \$15,000 a year. They are looking at the state GIC plan and the GIC look alike plan. These two plans do have higher deductibles and higher copays. They are comparing both plans to determine cost savings to the town. Linda asked what the town could do to increase the cost to the employee. Ed said the next Collective Bargaining Agreement contracts will include a 25% employee cost.

Ed said the Snow & Ice number came in at \$417,000 over the \$100,000.

Ed spoke about the solar project; 80% of electricity will come from this source. They plan to delete the utility line item from each department budget and create one line item in the budget.
