## TOWN OF PEMBROKE APPROVED ADVISORY COMMITTEE MINUTES 24 APRIL 2017

Chairperson Linda Peterson opened the meeting of the Advisory Committee in Pembroke Town Hall at 7:30PM on 24 April, 2017. Also present were Stephen Curley, Timothy Brennan, James McCollum, John G. Brown, Jr. and Elizabeth Monks Absent: Stephen Walsh, Richard McManus Guests: Mr. Bryant;

The committee received a Request for Transfer from the Reserve Fund from Deborah Wall, Library Director in the amount of \$7,000 for several repairs (HVAC) and some pending plumbing. There was a complaint of a potential allergic reaction (mold) in the History Room. The HVAC system has been a challenge to control and while we now seem to have a better handle on it with the new control system some rooms experienced high temperatures and this could have caused this issue.

Upon motion moved by Stephen Curley 2<sup>nd</sup> by Elizabeth Monks following the discussion it was

**VOTED**<sup>1</sup>: to approve a Request for Transfer from the Reserve Fund from Deborah Wall, Library Director in the amount of \$7,000 for several repairs (HVAC) and some pending plumbing. Timothy Brennan, James McCollum, John G. Brown Jr. supported the motion.

The committee reviewed Annual Town Meeting **Article 2** – to amend schedules A, B and C of the Classification and Compensation By-laws according to the schedules listed in Appendix D and to raise and appropriate, transfer from available funds.

Upon motion moved by Stephen Curley 2<sup>nd</sup> by Timothy Brennan following the discussion it was

**VOTED<sup>2</sup>:** Favorable Action - to amend schedules A, B and C of the Classification and Compensation By-laws according to the schedules listed in Appendix D and to raise and appropriate, transfer from available funds. The funding amount should be included in the article; it's primarily library employees and non-union. James McCollum, John G. Brown Jr. and Elizabeth Monks supported the motion.

Two new Recommendations have been added to the Annual Town Meeting Warrant Article 27 from the CPC. The committee reviewed the additional Recommendations:

**Recommendation L:** to appropriate the sum of \$15,000 from Community Housing Reserves and that said funds be granted to the Pembroke Housing Authority for the purpose of purchasing and installing a new backup generator at the MacDonald Way housing development, or take any other action relative thereto.

Stephen Curley believed funding was provided for a new generator four or five years ago from the Emergency Management budget. The committee agreed to send Brian Van Riper an email to confirm the purchase and understand what happened.

Upon motion moved by Stephen Curley 2<sup>nd</sup> by Timothy Brennan following the discussion it was

**VOTED<sup>3</sup>:** Town Meeting Floor - to appropriate the sum of \$15,000 from Community Housing Reserves and that said funds be granted to the Pembroke Housing Authority for the purpose of purchasing and installing a new backup generator at the MacDonald Way

housing development, or take any other action relative thereto. James McCollum, John G. Brown Jr. and Elizabeth Monks supported the motion.

**Recommendation M** – to appropriate the sum of 100,000 from Community Housing Reserves and that said funds be granted to the Pembroke Housing Authority for the purpose of installing new roofs at the MacDonald Way housing development, or take any other action relative thereto.

Upon motion moved by Stephen Curley 2<sup>nd</sup> by James McCollum following the discussion it was

**VOTED<sup>4</sup>:** Favorable Action - to appropriate the sum of \$100,000 from Community Housing Reserves and that said funds be granted to the Pembroke Housing Authority for the purpose of installing new roofs at the MacDonald Way housing development, or take any other action relative thereto. Timothy Brennan, John G. Brown Jr. and Elizabeth Monks supported the motion.

Timothy Brennan would like to review the committee's vote of Town Meeting Floor for Article 6 "to appropriate, transfer from available funds for the purpose of funding the cost of items of the first year of any collective bargaining agreements between the town and the Pembroke Patrolmen's association, Pembroke Permanent Firefighters Association, Council 93, Local 1700 (Town Hall), and Council 93, Local 1700 (Public Works), or take any other action relative thereto." There are rumblings of a prop 2 ½ next year; this should be explained to the residents.

Upon motion moved by Timothy Brennan 2<sup>nd</sup> by James McCollum to **reconsider** their vote for:

**VOTED**<sup>5</sup>: To **reconsider** their vote "Town Meeting Floor" for Article 6 - "to appropriate, transfer from available funds for the purpose of funding the cost of items of the first year of any collective bargaining agreements between the town and the Pembroke Patrolmen's association, Pembroke Permanent Firefighters Association, Council 93, Local 1700 (Town Hall), and Council 93, Local 1700 (Public Works), or take any other action relative thereto. Stephen Curley, John G. Brown, Jr. and Elizabeth Monks supported the motion.

The committee continued to discuss Article 6. If the funding was added to the budget this would not be an Article. The committee agreed to write to the Board of Selectmen about their concerns.

Upon motion moved by Stephen Curley 2<sup>nd</sup> by Timothy Brennan following the discussion it was

**VOTED**<sup>6</sup>: to keep their recommendation as Town Meeting Floor - for Article 6 - "to appropriate, transfer from available funds for the purpose of funding the cost of items of the first year of any collective bargaining agreements between the town and the Pembroke Patrolmen's association, Pembroke Permanent Firefighters Association, Council 93, Local 1700 (Town Hall), and Council 93, Local 1700 (Public Works), or take any other action relative thereto. James McCollum, John G. Brown, Jr., and Elizabeth Monks supported the motion.

The committee adjourned at 7:39pm to meet with the Board of Selectmen and Town Moderator to review the Articles for both the Annual Town Meeting and Annual Town Meeting.

Lew Stone, Chairperson of the Board of Selectmen welcomed Advisory and Stephen Dodge, Town Moderator and apologized for the delay of the meeting. Stephen Dodge explained this meeting is not to determine an outcome but to review procedures for the Annual Town Meeting so it runs smoothly. He reminded residents watching that the Annual Town Meeting is scheduled for Tuesday, May 9, 2017 @7:00pm at the Pembroke High School and that the Articles will be posted by the end of week and paper copies available early next week.

Stephen Dodge thanked Sabrina Chilcott, Board of Selectmen Executive Assistant for all her work preparing these documents.

Stephen Dodge noted a by-law was passed two years ago to allow the board to put together a Consent Agenda which includes non-controversial Articles which requires a 4/5 vote. These Articles are 1, 8, 9, 10 and 32.

Events such as road races requiring road closures with police and fire personnel involved. This information would also be posted on the town website as informational to residents.
