Health Agent Updates

Sanitary Code Violations at Two Commercial Locations

Cullity has a call into Santec to find out what the current status is for repairs to Pembroke Hospital. DEP is involved with the plans to fix this.

The second commercial property is still in the planning stages for a complete overhaul for the entire facility.

Board of Health Office Activity

Cullity reported the office activity has been picking up. Seven percs are on the board for then next 2 weeks and she expects more.

Bagni made a motion to table the 13 Points of Interest et al. to the next meeting (3/13/2017).

The Board started looking at each question. The Board added Sheila Landy to the organization chart showing she reports to the Town Administrator and the Board of health (Question 2). Cheryl Sbarra (MAHB) suggested Question 3 be answered as the Board of Health abides by General Law, Chapter 111 rather than listing each regulation individually.

The Board stopped examining the Town Study Committee to listen to Dan Lane from the CRR.

New Business P1 – 00:15:53

Dennis Lane, Executive Director, Coalition for Responsible Retailing (CRR)

Lane said the Coalition represents retailers that sell age controlled products (tobacco, alcohol, and lottery). He said the Coalition is not against the raising of the age to purchase tobacco but they would prefer it was state-wide. Lane was interested in consequences for purchase, possession or use of tobacco products. The CRR is against restrictions against flavored tobacco. Lane stated banning flavors would affect more than his tobacco sales due to people buying more than just tobacco at his establishment.

Cheryl Sbarra, MAHB

Spoke of statistics of marketing to young people. Offered an updated checklist to the Board ot formulate T21 Regulations. Bagni made a motion that the specifics of the T21 Regulations will be decided at the March 13, 2017 meeting. Fine seconded and all were in favor.

Anna Bettencourt, Verc Enterprises

P2 - 00:00:00

Bettencourt requested the ban not be on flavors.

Lisa Wells, Smoke and Ashes

Asked the Board to not ban flavors and also not to follow Whitman's lead and allow flavors to be sold at 21 only establishments.

Old Business

Town Study Committee Questionnaire (continued)

P2 - 00:10:32

Fine made a motion to accept the report as written with the exception of adding Landy to the organization chart. McSweeney seconded and all were in favor. (Exhibit B)

Cannabis Committee

P2 - 00:14:00

Fine reported there will be a ballot question at the annual Town Meeting and the next Cannabis Committee meeting will be after Town Meeting.

Plastic Bag Initiative/Survey Monkey

P2 - 00:14:33

There were five questions discussed regarding banning one-time use plastic bags from retail establishments. Fine requested the order be changed (Question 5 was flipped with Question 4. Bagni made a motion to flip Questions 4 and 5, Fine seconded and all were in favor. (Exhibits C) Job Description

Board discussed strategy for wording the description of the Health Agent. The Agent has 20 years of experience in the Town of Pembroke in various capacities. McSweeney would like to look at stopping the outsourcing of food inspections in the interest of saving money. Each inspection costs \$50 when done by outside contractors. Fine made a motion to table McSweeney's suggestion to the next meeting. McSweeney requested it by the March 27, 2017 meeting (when she returns from vacation). McSweeney seconded the amended motion and all were in favor.

Food Service Regulations – Presentation of documentation by McSweeney.

McSweeney did not make a presentation. The documents were submitted to the Board for educational purposes. McSweeney may bring ServSafe up again after she reviews the inspection records she requested under Public Records Law. (Exhibit D)
