

## MINUTES OF THE PEMBROKE BOARD OF HEALTH MEETING

# July 12, 2022 at 6:00 P.M. Board of Health Office, Town Hall Room #5

**PRESENT**: Matt Newman (Acting Chair), Maureen Jasie (Member), Sheila Landy (Secretary), and Joseph Webby (Webby Engineering)

Matt Newman opened the meeting at 6:00pm and read the statement about the recording of the Meeting.

**BOARD ACTION ITEM** – Discuss and Vote Variance Request for 16 Parker Road – Webby Engineering Joe Webby explained the variances requested for 16 Parker Road, a small 50' by 100' lot. Webby is requesting four variances to get maximum feasible compliance. Jasie made a motion to approve the variances as written. Newman seconded and the motion passed.

**BOARD ACTION ITEM** – Discuss and Vote Perc Extension for property on Taylor St This comes up yearly and is the only property in town to diligently renew the perc yearly. Newman made a motion to extend the perc another year, Jasie seconded, and the motion passed.

**BOARD ACTION ITEM** – Discuss and Vote Unlicensed Livestock and Crowing Rooster Violations on Chapel Street

Newman stated the property on Chapel Street no longer has a rooster and the livestock has been registered with the Board of Health Office. Newman tabled this indefinitely in case the issue comes back.

## BOARD ACTION ITEM – Vote to accept the Minutes of May 18, 2022

The secretary said they were not ready, and Newman tabled this item to the next meeting.

## **CORRESPONDENCE – Letter sent to Maureen Jaisie**

Jasie received a letter addressed attention to her at Town Hall from Eamon Fee. Mr. Fee purchased a property on Barker St (Sherman Airfield) and was having a meet and greet at his property to discuss his plans for the property. He is putting a large shed on the property (going before zoning) to house the equipment used on the property and wanted the abutters and other citizens of the Town to understand his intent. The letter was an invitation to visit the property on July 11<sup>th</sup> at 7:30pm to discuss his intent.

## **HEALTH AGENT REPORT**

Office Activity – Title 5's are up. Market is heating up but interest are going up. A fair amount of failures. Lots of new septic systems (repairs) going in. It has slowed a little bit with the Holiday weekend.

COVID positivity is on the rise in MA. Boston sewer water testing indicates the cases are climbing in MA. Our nurse indicates we are not seeing a rise in hospitalizations or serious illness. There are some mild cases in Town Hall. Protocols have not changed if you are sick. Use common sense we use for any illness.

Office vacations are coming up but the office should be covered for most days.

Newman set a tentative date of August 16<sup>th</sup> at 6:00pm for the next meeting.

Landy said she had to check with Robert DeMarzo about the Livestock Subcommittee joint form to do go over proposed changes to the Livestock Regulations. Newman and Landy brought Jasie up to speed up the proposed changes. The subcommittee and the BoH would like to make everyone, livestock owners and non-livestock neighbors, be good neighbors and be humane to their livestock.
