To consider a request for an amendment to the Order of Conditions (DEP file number SE56-928) issued to Willard J. Boulter Jr., Chairperson of Water Wheel Committee, by the commission on April 22, 2013 and subsequently appealed by Willard J. Boulter, Jr., Chairperson of the Water Wheel Committee, to the Massachusetts Department of Environmental Protection on May 6, 2013. The request for an amendment to the Order of Conditions was filed on April 25, 2016 by Willard J. Boulter, Jr., Chairperson of the Water Wheel Committee, 100 Center Street, Pembroke MA to allow the temporary water wheel to remain in place permanently without time of year restrictions (Special Conditions No. 2A and No. 3); modify the language of Special Condition No. 2C to read "The weir shall be returned to its original condition. When the wheel is moved to the permanent location the metal structure holding the wheel in place shall be removed."; replace Special Condition No. 3 to read: The Operation and Maintenance Plan regarding the water wheel shall come under the Massachusetts Division of Marine Fisheries and the Pembroke Herring Fisheries Commission and the Pembroke Conservation Commission. Both the State and Pembroke Town laws give authority to these organizations to regulate the Herring Fisheries brooks and streams located in this area."; modification of the safety fencing requirements in the area of the water wheel to allow viewing of migrating herring (Special Condition No. 5); modify the language of Special Condition No. 6 to read: "Any signs connected to the Order of Conditions must be approved by the Building Inspector. Any sign erected in this location will not be placed into the water and will be removed upon transfer of the wheel to the permanent location." at the Herring Run Park, Barker Street, Pembroke, Massachusetts as shown on Assessor's Map D10, lot 2.
