**ARTICLE 1:** To see if the Town will vote to transfer from available funds the sum of \$5,430 to provide for the unpaid bills from FY2013 listed below, or take any other action relative thereto:

**ARTICLE 6**: To see if the Town will vote to raise and appropriate, transfer from available funds, and/or borrow a sum of money for the purpose of developing a new Water System Master Plan, or take any other action relative thereto.

EXPLANATION: This article will cover the engineering services for the Water Division new 10 year Capital Plan to be paid from Water Surplus in the amount of \$45,000. Borrowing requires a 2/3 majority vote.

**ARTICLE 7**: To see if the Town will vote to raise and appropriate, transfer from available funds and/or authorize the Treasurer to borrow, a sum or sums of money for the purpose of purchasing a new Half Ton Extended Cab 4X4 Pick Up Truck, or take any action relative thereto.

EXPLANATION: This truck will replace a 2008 hand me down police cruiser that is now parked for the next Surplus Property Auction for scrap. Borrowing to be paid back by Water Revenue in the amount of \$25,000. Borrowing requires a 2/3 majority vote.

**ARTICLE 8:** To see if the Town will vote to raise and appropriate, transfer from available funds and/or authorize the Treasurer to borrow, a sum or sums of money for the purpose of purchasing a new 4X4 Backhoe and Attachments, or take any action relative thereto.
