MINUTES OF THE SELECTMEN'S MEETING OCTOBER 1, 2019

At 7;30 pm Mr. Boulter opened the meeting.

7:30 PEMBROKE BOARD & COMMITTEE COLLABORATION – COMMUNITY PRESERVATION COMMITTEE

Lisa Cullity, Chairperson of the CPC was present to give the Board an overview of the Committee's charge and how it operates with applications from departments, organizations and individuals for funding from the program. She discussed the makeup of the Committee, its meeting schedule before and after town meetings and the percentage of each property tax (1%) that goes towards the CP Fund with varying contribution levels from the Commonwealth. She also discussed that there was one vacancy on the Committee.

DISCUSSION: VOTE TO APPOINT ALTERNATE TO TOWN MANAGER SEARCH COMMITTEE

Mr. Boyle moved and Mr. Trabucco seconded the motion to appoint Selectman John Brown to the Town Manager Search Committee as an Alternate. The vote was unanimously in favor.

Ms. Rushing moved and Mr. Boyle seconded the motion to appoint Michael Murphy, 120 Old Washington Street to the Recycling Committee. The vote was unanimously in favor.

DISCUSSION: POSSIBLE VOTE ON REPARATIONS OPTIONS ON RT. 27 - CITY OF BROCKTON

Mr. Thorne informed the Board that the City of Brockton had fulfilled its obligation to complete the water line work on Rt. 27 (School Street) as previously requested by the Board. No action was taken.

DISCUSSION: VOTE TO APPROVE MINUTES OF SEPTEMBER 24, 2019

Mr. Boyle moved and Ms. Rushing seconded the motion to approve the minutes of September 24, 2019. The vote was unanimously in favor.
