## Request for Determination of Applicability (RDA) 260-280 Oak Street – Murphy

The subject proposal originated with a complaint of land clearing by Mr. Murphy. MassGIS wetlands maps indicated the presence of a wetland resource area located on the site. As a result Mr. Murphy was requested to file a Request for Determination of Applicability. Mr. Brad Holmes of ECR presented his findings on behalf of the applicant. In November of 2015, ECR reviewed the site and adjacent parcels to evaluate existing conditions and to determine if the site contained wetlands within 100 feet of the site's boundary. As a result of this review, Mr. Holmes determined that the site was entirely upland and lacking wetland resource areas on or near the site. He has since alerted MassGIS that there is an error in the mapping. Agent Bob Clarke states that GIS is a great tool and that the conservation commission does rely on the data contained therein. The ground work performed by Mr. Holmes confirms the error in mapping. Mr. Clarke also states that the commission prefers that the applicant approach the conservation commission prior to performing any activity on a site.
