Appointment: Interview with Rachel Michael, candidate for Administrative Agent position vacancy

Ms. Michael has submitted a very impressive resume of credentials for the position. In addition, she is currently working as the executive assistant for the Community Preservation Committee and is a Pembroke resident. Ms. Michael fields questions from the commission on the professional experience listed on her resume.

During the questioning session, the commission introduces themselves to Ms. Michael and provides a brief biography of their own interests in serving on the conservation commission.

Agent Bob Clarke informs the commission that Ms. Michael has been into the office and understands how it works. She was also a contender for the position 3 ½ years ago when the current Administrative Agent was hired. He is very happy that she applied again. Mr. Clarke explains that the position is under the direction and supervision of the conservation commission and is eligible for benefits. Office hours for the position are flexible and can be arranged to suit Ms. Michael's schedule, if she chooses. He has asked if Ms. Michael is available to work on an interim/temporary basis for the commission and she has agreed.

The position was advertised by the town administrator's office with a closing date of February 24, 2017. To date, Ms. Michael is the only applicant for the position that the commission knows about.

Agent Bob Clarke requests that Ms. Michael be registered to attend the upcoming MACC conference so that a place can be held for the successful candidate.

Chairperson Andy Stevenson makes a statement on behalf of the board thanking the current administrative agent Mary Guiney for her service and commitment to the commission. He wishes her well in her new position.

### Discussion: Indian Head River (IHR) Trail Grant Program

Agent Bob Clarke updates the commission on the status of the application which was submitted during the week. The application contains letters of support from the Towns of Hanson and Hanover; Hanover Open Space Committee; Wildlands Trust; North/South River Watershed Association; and Doctor Roberts.

# <u>Discussion: Solutions for Health Waters Conference, March 16, 2017 at Camp Kiwannee, Hanson</u>

Member Art Egerton has been hired to videograph the conference. A copy of the conference overview is included in the mail folder. Member Rick Madden would like to attend. Member Scott Glauben wants to check his schedule as he too would like to attend. Administrative agent Mary Guiney informs the commission that she as sent an email requesting a payment voucher from the coordinators so that commission members can register and attend. Mr. Glauben requests that the item be put on the next agenda for further discussion.

# Request for Certificate of Compliance (COC) -19 Canoe Club Lane (DEP file no.: SE56-927)

Agent Bob Clarke is recommending the issuance of a complete COC for this property as the site is substantially complete. Member Scott Glauben does not agree – the site is sloppy.

# Order of Resource Area Delineation (ORAD) – 70 Old Cart Path Lane (DEP file no.: SE56-977)

Agent Bob Clarke reminds the commission that at the last meeting the applicant's representative stated that he relied on the 2015 USGS map to determine that the river was intermittent and not perennial. Both Mr. Clarke and administrative agent Mary Guiney have been pushing the representative to provide the map that he relied on for the determination. Mr. Clarke and Ms. Guiney have also reviewed MassGIS, the current USGS map available in the conservation office, and historic topographic maps which indicate that the river is perennial. A copy of the map and correspondence received on this date from the representative revealed that the wetland scientist relied on a MassGIS topographic (an amalgamation of various quad maps) to make his determination. He did not pull and review the actual USGS quad map for the site. After a review of the map and correspondence, Agent Bob Clarke is recommending that the commission vote to designate the stream as perennial on the ORAD.

Mr. Clarke makes a motion to issue the ORAD with the following conditions:

- "ACCURATE: The boundaries described on the referenced plan(s) above and in the Abbreviated Notice of Resource Area Delineation are accurately drawn for the following resource area(s):
- -Bordering Vegetated Wetlands
- -Other resource area(s), specifically: Top of Bank for the east side of the perennial stream was determined to be accurate.

MODIFIED: The boundaries described on the plan(s) referenced above, as modified by the Conservation Commission from the plans contained in the Abbreviated Notice of Resource Area Delineation, are accurately drawn from the following resource area(s):

-Other resource area(s), specifically: The intermittent stream as shown on the plan has been determined to be perennial based on a review of the USGS maps and field observations of the site.

INACCURATE: The boundaries described on the referenced plan(s) and in the Abbreviated Notice of Resource Area Delineation were found to be inaccurate and cannot be confirmed for the following resource area(s):

- Other resource area(s), specifically: The intermittent stream as shown on the plan has been determined to be perennial based on a review of the USGS maps and field observations of the site.
