Board: No holdup on FiOS from town

"Hopefully, this gentleman will have his problem resolved," he said.

Stone also denied claims that selectmen are holding up Verizon from bringing FiOS to town.

"Nothing is further from the truth. The board welcomes Verizon to come into town to provide competition to the local cable company," he said.

Selectmen Chairman Dan Trabucco said that at the last Old Colony Planning Council meeting he attended there was a discussion about a new fiber optic highway that is going to be put in from Brockton through Cape Cod and the Islands and back. He said a company has received federal funds to do the project.

"This is like Route 3 and Route 495," he said. "It's going to take a couple of years."

Trabucco said he believes Verizon and Comcast are waiting for the fiber optic infrastructure to be complete, so the companies do not have to pay to put it in themselves but can tie into it later.

In other business, Selectman Greg Hanley said selectmen should invite the Pembroke Historical Society to a meeting.

Hanley said the historical society has applied for and received grants in connection with the town's tercentennial celebration in 2012. He said the 300th anniversary committee has had no suck luck with grants.
