#### **DECA Presentation**

Mrs. Obey said three students of the 25 students that qualified for states are here tonight to talk about DECA. Mrs. Gates introduced herself as the DECA Advisor and said when the club started three years ago there were 25 members and this year there are 86. The students explained that DECA competes at the district, state and international levels. They described what a competition entails and said it is really fun and a great opportunity to make friends. Mrs. Gates said 25 students will be going to the State

competition in March. She said from there is the International competition in Tennessee which will have 17,000 students from across the US.

## Update on Pearson enVisionMath2.0: Dr. Catherine Glaude

Mrs. Obey said about forty parents attended the math night. Dr. Glaude showed the committee a video of a math class at Bryantville. Mrs. Russell said math is different than in the past and the first graders are coming up with different strategies to solve the same equation. She said enVision2.0 is allowing students to use strategies that work for them. Mrs. Murphy, a fourth grade teacher at Hobomock, said enVision2.0 allows the teachers to pick and choose what they want the students to do because there is so much available. Mr. Murphy said this program allows the students to solve things a different way and brings a sense of ownership. Mrs. Shadrick, a fifth grade teacher at North, said enVision2.0 is great because it is differentiated for the teachers so they can pull out what is needed. She added that the students are enjoying it and are engaged. Mrs. Palenstijn said she is a first year teacher at North and said she has learned so much about enVision2.0 during the recent math professional development day. Mrs. McFadyen, a sixth grade teacher at North, said what she likes most about enVision2.0 is the amount of flexibility to find out what works best for each teaching style. She added that the multiple strategies for problem solving is great. Mrs. Obey said there will be more professional development for teachers surrounding enVision2.0. Mr. Tropeano suggested supplying parents with tutorials so that they can understand the new program. Mr. Bosworth questioned bandwidth capacity as the students are working more online. Mrs. Obey said Mr. Doyle is working with the elementary schools to figure out the best places for the hotspots. She added that there is a computer based center in each of the upper grades of the elementary schools. Mr. Chilcott asked how this elementary math program will tie into middle and high school and Dr. Glaude said Mr. Duffy works with the elementary principals monthly and he believes the students will be more successful at the secondary level having had this program in K-6. Mrs. Wandell said continual parental communication about the program is a good idea.

## Selection of Representatives for Superintendent Search Committee

Mr. Tropeano said the pool of candidates is very strong. Mrs. Obey said the three teachers are Lynn Place from PHS, Kathie Adams from Bryantville and Meghan Crehan from Hobomock. The Administrators are Jessica Duncanson and Michael Murphy.

Mr. Chilcott said Mrs. Scroggins couldn't be here but wanted to support Tom Hogan and Jim Agnew for parent spots on the committee. He said she also supports James Porter for the community spot.

Mr. Bosworth chose Kathy Chandler. Mrs. Wandell chose Mr. Porter and Mrs. Chandler. Mr. Chilcott chose Mr. Porter and said Mrs. Chandler was his second choice. Mrs. Wandell said there are eight educators in the pool. The committee set aside Mr. Porter and Mrs. Chandler as the options.

Mr. Chilcott said Mr. Agnew and Mr. Hogan are his choices. Mr. Bosworth said he chooses Sandra Beaton Small for Bryantville and Mr. Chilcott said he choose her also. Mr. Bosworth said he supports Mr. Agnew also. Mrs. Wandell said Mrs. Quatrale is her choice for North Pembroke. Mr. Bosworth said he chose Evanthia Bathos and Mrs. Wandell and Mr. Chilcott agreed. The committee decided on:

Mr. Chilcott said he highlighted Mr. Goodman and Mrs. Dahlquist as both are very involved in the community and their children went through the entire system. Mr. Chilcott said Mrs. Scroggins choices were Mrs. Bathos, Mrs. Quatrale, Mrs. Small, Mr. Hogan, Mr. Agnew and Lance Kennedy.

He said the search committee will receive the applications via email after the closing of the posting on 1/29.
