- 7:15 Discussion about proposed "IGolf" entertainment facility in existing "Sun & Ski Sports" building at 296 Old Oak Street, which would offer indoor golf, axe throwing, darts and cornhole, with a small bar. Possible vote to waive site plan review or approve as minor modification to existing site plan.
- 7:25 Vote to return remaining balance of escrow account for visual screening for Site Plan #SP7-16 Hobomock Solar Project to applicant and/or developer
- 7:30 Possible vote to approve two proposed signs at 43 Mattakeesett Street in Center Protection District
- 7:45 Discussion about possible restaurant and micro-distillery at 300 Center Street (former location of Arrow Restaurant)
- 8:00 Discussion about possible alteration of Site Plan #SP1-09 King's Highway Park (at 242-246 Washington Street) to change use of projected building from commercial to multifamily residential
- 8:10 Review of routine administrative matters, including possible approval and signing of building permits, and possible vote to accept minutes of July 27, 2020
- 8:15 Discussion about possible change of use in existing mixed-use building at 8 Main Street, to convert portion of commercial space into two apartment residential units
- 8:30 Executive Session pursuant to G.L. c. 30A, Section 21(a) purpose number 3: "To discuss strategy with respect to...litigation if an open meeting may have a detrimental effect on the...litigating position of the public body and the chair so declares." Specifically, the Board will discuss and take appropriate action with respect to the matter of Town of Pembroke Planning Board, et al. v. Town of Pembroke Board of Zoning and Building Law Appeals, et al., Plymouth County Superior Court Case No. 1983CV00239 regarding Pembroke Center Street, LLC, and the property located at 204 Center Street in Pembroke.
