

Attention MMHG Medex Members:

NEW- Your Medex Plan now includes benefits for acupuncture!

Here's what you need to know:

- ⇒ Effective July 1, 2019, coverage for acupuncture services, furnished by any licensed acupuncturist, was added to the Medex plan.
- ⇒ Important: In order for acupuncture benefits to be covered (up to 12 visits per year) and to pay appropriately, the PROVIDER or the MEMBER must submit the claim directly to BCBSMA. If the claim is submitted to Medicare first, it will deny by both Medicare and Medex.
- ⇒ Ask your provider if they can file a claim directly with BCBSMA. If not, you will need to pay up front, and file a claim for reimbursement.
- ⇒ To file a claim for reimbursement you must fill out a claim form, attach your original itemized bills, and mail the claim to Blue Cross Blue Shield (follow directions on the attached claim form).
